Avigilon Security Camera System Software, Camera Licenses, and Servers

Grand Valley State University is accepting proposals for Avigilon security camera system software, camera licenses and three new servers for its security system on the Allendale campus.

GVSU RFP #218-50: Introduction

Grand Valley State University is replacing its existing ONSSI security camera system with an Avigilon system on its Allendale campus. Control Center software, 281 each camera licenses, and three Avigilon HD NVR Premium servers are needed. GVSU will use its existing cameras. This is the first phase of a three year project. The equipment and service for years two and three will also be bid out each of those years. Years two and three may include license plate cameras and additional cameras/server for parking lots and residence halls.

Each supplier should acknowledge receipt of any addenda in their proposal on the Proposal form, but the failure of a supplier to receive or acknowledge receipt of any addendum, shall not relieve the supplier of the responsibility for complying with the terms thereof.
- 3. If you are submitting your proposal via mail or drop-off, include an electronic copy of your proposal via either CD, or USB drive.
- 4. It is GVSU's preference to award this RFP to a single supplier. Please price based on being awarded the entire RFP. Grand Valley State University reserves the right to accept or reject any or all proposals.

GVSU RFP #218-50: Specifications

- 1. Bid on new equipment; no rebuilt equipment allowed. No substitutes allowed.
- 2. State of Michigan Prevailing Wage law is applicable for the installation labor. Attached are the current Prevailing Wage rates for Ottawa County. Contact the State of Michigan if questions at 517-322-1825.
- 3. Include <u>all</u> costs in your proposal including freight, delivery, and installation as F.O.B. destination GVSU Campus, Allendale, Michigan. Provide an itemized cost list if optional or variable costs.
- 4. Quote cost on the following:
 - 1 each Avigilon Control Center software system including an upgrade to the new software version if Avigilon releases a new version within the first year of purchase.
 - 281 each Camera licenses
 - 3 each Avigilon HD NVR Premium servers (84 TB or larger)
- 5. Include item description with manufacture product numbers.

6. Delivery and switchover from ONSSI system to Avigilon system.

- a. Server installation on GVSU site to be determined (IP and networking information will be provided by GVSU prior to installation).
- b. All server specifications and manuals must be submitted with RFP.
- c. Conversion/setup of existing cameras to work on Avigilon system Troubleshooting of any camera/server issues found during system installation.
- d. Failover set up for all cameras to a secondary Avigilon server.
- e. Disaster recovery plan with setup for server operating systems and software utilizing the other Avigilon servers.
- f. Time and material costs for on-going server maintenance.
- g. Time and material costs for on-going camera maintenance.
- h. Staff/User on-site training costs.
- i. Administrator off-site or, if available, on-site training costs.
- j. Quote as a separate line item, 3-yer maintenance agreement on the server
- k. Quote your labor rate for repair and replacement of cameras? Are you willing to lock that in for three years?
- 7. Prior supplier performance will be considered in evaluation.
- 8. GVSU needs 30 days payment terms on invoices. However, if an invoice is approved to pay sooner than 30 days GVSU does pay it immediately. Invoices may be e-mailed to GVSU Accounts Payable at payables@gvsu.edu.
