## GVSU RFP #219-14 DeVos Display Exhibit: Specifications

### Background

Grand Valley State University seeks a turnkey supplier to provide exhibit concept and design, fabrication, and installation for a permanent exhibit to honor and remember Richard and Helen DeVos in the university's Richard M. DeVos Center on the Robert C. Pew Grand Rapids Campus in downtown Grand Rapids. It is expected that the exhibit will include both static display areas and interactive electronics. The university is seeking one supplier to supply and/or coordinate all aspects of the project except content, which will be provided by the university.

A benchmark for this project can be found in our L. William Seidman Center lobby in the Seidman Timeline honoring founder Bill Seidman (see Appendix A photos). The L. William Seidman Center is located at (50 Front Ave. SW, Grand Rapids, MI). You may park in the Mount Vernon lot or the Watson lot.

#### **Project Objectives**

- 1. Using content provided by the university, design a concept for a permanent display covering the four primary areas of content: Personal story, Grand Valley State University impact, West Michigan impact, Motivational quotes.
- 2. Design and build out approved concept for physical and interactive display, acting as the general contractor for any external suppliers (anticipated costs for external suppliers should be included in the RFP).
- 3. Procure and install physical display in coordination with university team.
- 4. Trouble shoot and provide any needed adjustments for one month following installation.

#### **Requirements and Considerations**

- 1. See DeVos Display Project Plan below on page 6
- 2. Proposals will be evaluated on the following assumptions about the display. The university understands that these details will change and may alter the original bid. This RFP will allow us to compare suppliers, knowing that concept details could alter the actual cost.
- 3. Specifications:
  - Two static display panels within the rotunda area to either side of the exit door in the DeVos Center Building C plaza atrium rotunda round (see Appendix B photo of rotunda area).
  - Two interactive digital screens for primarily video content, one per panel.

- 4. The university will provide
  - Content strategy
  - Video content
  - Text content
  - Images
  - Artifact content as appropriate
- 5. The supplier should provide:
  - Graphic design
  - Structure design
  - The physical building of the panels
  - Procurement and programming of the digital screens including any software
  - Installation of the panels
  - Initial trouble shooting and maintenance for one month
- 6. Cost estimating:
  - Please use the general specifications above to estimate time and material costs, with the understanding that these are very broad specifications and the actual costs could vary widely in the end project. A final budget will be established at the concept phase of the project once all creative ideas are vetted.
  - Base material costs on what was used in the Seidman Timeline exhibit noted as the benchmark for this project.
- 7. State the specific team members that will be committed to this project with the specific role and level of involvement for each. Include experience.
- 8. Provide three client references (names, contact information) for projects comparable to GVSU's. Describe the scope of the project.
- 9. Evaluation criteria:
  - Assessment of creative competency
  - Evidence of like work/projects
  - Assessment of staff team expertise assigned to project
  - References
  - Costs
- 10. GVSU will provide a single point of contact with the supplier to streamline communications and approvals and reduce costs.

# Objective

Establish a permanent display to celebrate the impact Rich and Helen DeVos have had on this community and on Grand Valley State University so it is available to students in the future, and to share their story as an inspiration to students.

Key Themes

- Rich and Helen DeVos were from West Michigan, became successful in West Michigan, and generously shared that success with our community.
- Grand Valley State University would not be the school it is without the vision and leadership of Rich DeVos, and without the financial support of Rich and Helen DeVos.
- Rich led the foundation for 24 years and served on the Board of Trustees.
- He led the charge for the downtown campus and formed the Land Barons.
- Helen cared deeply about education and served on the foundation advisory board. She was a true partner in their support for Grand Valley.
- Their story is inspiring to young people and they were great role models for the qualities and values that lead to successful and fulfilling lives.

Physical Considerations

- Approximately the size/scope of the Bill Seidman display, possibly in parts or rounded to fit the space
- Digital screen for video/audio (must be maintained)
- Museum-like display around the digital screen
